### **Students Feedback on current syllabus**

#### (Under Graduate)


There are 07 under graduates courses running in the college and the IQAC decided to choose 20 percent students from each class of each course to take students feedback on the current syllabus. The sample size for the feedback turned out to be 145. The data were collected with the help of a structured questionnaire.

The responses received from the respondents are presented in the following table.

Around 97.9 percent of the respondents opined that the course fulfilled their learning needs. 95.2% students felt that the structure of the syllabi is systematic with adequate examples. 97.2% of the students were of the opinion that the course exposed them to practical knowledge followed by 94.5% that the course seems useful in getting the job. However, 91.7% students felt that the topics included are of equal importance.

While answering the question regarding the adequacy level of the course 64.8% students agreed that the level of the course was adequate, whereas 34.5 percent felt that it was too high. However 0.7% felt that level of the course was too low.

(Post Graduate)


There are 07 PG departments in the college and the IQAC decided to choose 50 percent students from each class of each department to take students feedback on the current syllabus. The sample size for the feedback turned out to be 59. The data were collected with the help of a structured questionnaire.

The responses received from the respondents are presented in the following table.


# PG Teachers Feedback on current syllabus


### **UG Teachers Feedback on current syllabus**

From the above data it is observed that all the teachers of the institute felt that No. of Periods allotted per week for the course is sufficient and Syllabus includes useful textbooks. 98.2% teachers felt that syllabus accurately describes the course. However 74.5% teachers agreed that the syllabus offers the research possibilities as well as Possibility of community projects related to the course. 87.3 percent of the teachers were of the opinion that the syllabus entails reference work. 92.7% teachers felt that Textbooks covering the entire syllabus are available and syllabus induces mental exercise on the part of students. However 94.5 % teachers felt that allotted time to complete the syllabus is sufficient.

From the above data it is observed that 93.3% alumni students felt that the course fulfilled their learning needs and objectives after completion of course.
